- ✓ Submit the **CSS/Financial Aid PROFILE** Application on or before **MARCH 2, 2011**
 - Application website is <https://profileonline.collegeboard.com/index.jsp>
 - HMC's CSS Code is 4341

- ✓ Submit the **FAFSA** Application on or before **MARCH 2, 2011**
 - Available on January 1, 2011
 - Application website is www.fafsa.gov or you can obtain a paper FAFSA by calling the Federal Student Aid Information Center (FSAIC) toll-free at (800) 4-FED-AID or (800) 433-3243. You may request up to three copies of the paper application and should receive the FAFSA in 3 to 7 business days.
 - HMC's Federal School Code is 001171
 - A parent and/or student PIN(s) for use in lieu of the paper signature page can be obtained from www.pin.ed.gov

- ✓ Mail a **GPA Verification Form** on or before **MARCH 2, 2011**. ***Mail Early!***
 - California residents not currently receiving a Cal Grant can apply for the Competitive Cal Grant program by submitting a GPA Verification Form to the California Student Aid Commission
 - A GPA Verification Form will be available at www.csac.ed.gov in November 2010 to fill out and print.
 - Rising sophomores must submit their GPA Verification Forms to their high schools for certification.
 - Current upperclassmen who choose to apply for the Competitive Cal Grant must have their GPA Verification forms completed by the HMC Registrar's Office.
 - Continuing Cal Grant recipients do not need to submit the GPA Verification Form.

- ✓ Submit the following documents with the **Cover Sheet** (available at <https://idoc.collegeboard.com/idoc/index.jsp>) to The College Board Institutional Documentation Service (IDOC) on or before, but no later than **APRIL 15, 2011**
 - **2010** signed student and parents' federal tax returns, including all Schedules, Forms, W2s and 1099s
 - **2010** signed corporate and/or partnership federal tax returns, including all Schedules, Forms, and other documentation
 - **Noncustodial Parent's Statement** from the noncustodial parent of rising sophomores is required. Upperclassmen who have not submitted two years of noncustodial parent information must submit the Noncustodial Parent's Statement
 - **Dependent Verification Worksheet**, if required by the SAR response to the FAFSA application
 - **Business/Farm Supplement (entirely)**, if your parent did not complete all Schedules on the **2010** corporate and/or partnership federal tax returns (i.e. Schedule L Balance Sheets per Books)

A **Cover Sheet** is provided by The College Board in response to filing the CSS/Profile Application. Only one packet of documents accompanied by the **Cover Sheet** should be sent to The College Board.

- ✓ Submit other documentation and forms requested by the Office of Financial Aid on or before **APRIL 15, 2011**.
