The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). **Insurance Information:** The plan has a contract with Anthem Blue Cross Life and Health Insurance Company to pay health and prescription drug claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2012 were \$11,909,287.

The total premiums paid for the plan year ending December 31, 2012 were \$10,498,586.

Insurance Information: The plan has a contract with Gerber Life & Accident Insurance Company to pay business travel accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2012 were \$1,070.

**For The Claremont Colleges Employee Assistance Plan**: This is a summary of the annual report of the The Claremont Colleges Employee Assistance Plan, EIN 95-4786748, **Plan No. 512**, for the period January 1, 2012 through December 31, 2012. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Insurance Information: The plan has a contract with U.S. Behavioral Health Plan, California DBA Optum to pay employee assistance program claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2012 were \$109,396.

**For The Claremont Colleges Dental Plan**: This is a summary of the annual report of the The Claremont Colleges Dental Plan, EIN 95-4786748, **Plan No. 517**, for the period January 1, 2012 through December 31, 2012. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). **Insurance Information**: The plan has a contract with Delta Dental of California to pay dental claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2012 were \$1,016,202.

**For The Claremont Colleges Vision Plan**: This is a summary of the annual report of the The Claremont Colleges Vision Plan, EIN 95-4786748, **Plan No. 521**, for the period January 1, 2012 through December 31, 2012. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). **Insurance Information**: The plan has a contract with Vision Service Plan to pay vision claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2012 were \$155,905. Because it is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2012, the premiums paid under such "experience-rated" contract were \$155,905 and the total of all benefit claims paid under the contract during the plan year was \$143,118.
