Dear Laura:

We appreciate receiving your proposal for the Thematic Pathway Review (TPR), "Healthy Excellence: Putting Success in Perspective." Below we provide some general comments that emerged from reading all the proposals and specific feedback related to your submission.

WSCUC staff reviewed the twelve thematic proposals submitted from the second cohort of institutions with Accreditation Visits scheduled for spring 2021, fall 2021, and spring 2022. The proposals represent a wide range of issues and topics and address important and meaningful questions that will engage institutions with complex issues. Some common themes were student success; equity, inclusion and diversity; and curriculum issues. Themes were developed through inclusive processes with multiple feedback loops involving key stakeholders, and proposals were well aligned with CFRs. Some but not all proposals had clear timetables for completion of the work and expected deliverables. We also found that many were of a degree of complexity and comprehensiveness such that they are probably not fully achievable by the date of the visit. As you move forward, we ask that you carefully consider what can reasonably be accomplished by the time of your institutional report and visit. Please share this question with your planning committees. A timeline may help to focus your work, if you don't already have one. Additionally, the success of an institution's work can best be evaluated if there are specific outcomes, evidence of whether outcomes are achieved, and an indication of how the results have been used. Teams look for analysis and reflection, not just description.

In terms of specific feedback, we note that the Harvey Mudd College proposal identified themes that are important to the institution, are widely supported by campus stakeholders, and are expected to lead to improvements in wellness, culture, curriculum and co-curricular programs. The projects proposed are ambitious, and some work has already been undertaken in these areas that lay a foundation for success. In terms of the co-curricular project, we wondered whether the review of the four co-curricular programs might lead to a general template or strategy for examining the effectiveness of other co-curricular programs at Harvey Mudd at some future time. In terms of the overall proposal, we suggest that you think about the specific deliverables for your institutional report, which will be due ten weeks before the Accreditation Visit in spring 2021. It may be helpful to develop a detailed timeline that would unpack the items in the chart on page 7 with more specificity to indicate, for example, key tasks, critical dates, responsible groups or individuals, expected outcomes, and deliverables to ensure that the institutional report includes some completed projects, with evidence of using the findings for improvement. Note that not all aspects of all projects need to be completed by the time of the review. However, you will want your institutional report to show evidence of some completed activities and the plans for finishing what remains.
